Noteworthy Technical Updates

The EEA's technical groups have continued to make progress. Here are a few updates:

- **The Legal Advisory Working Group** held a session last week on governance tokens for DeFi.
- **The Testing Working Group** identified a bug on an earlier approach that has been fixed. They are looking forward to a range of enhancements that will enable members to deploy their own tests in a permissioned blockchain network.
- **The Off-chain Trusted Computing Group** is working to clarify the parts of the technology where there are applications beyond blockchain, while ensuring that we continue to support the core approach of enabling ethereum blockchains to use enclaves for better privacy and performance.
- Along with publishing their use cases and working on their first specification, the **Cross-Chain Interoperability Group** is looking at integrating the extensions they developed into the EEA's main architecture stack diagram -- a discussion that will start in October with the Tech Spec Working Group.
- **The Techspec Working Group** is targeting a November release of the next specifications cycle -- Client Specification v6 and Permissioned Blockchain Specification v2.

The technical work proceeds most effectively when there are a diverse set of stakeholders providing feedback. So, whether you represent a blockchain client developer, a customer wanting a client to run in a consortium, or a software integrator providing tailored solutions or other tools, your input can influence the work and ensure that it meets our goal of solving real problems for real enterprises, large and small. DeFi Protocols Break \$10 billion in Total Value Locked

There are now over \$10 billion in assets locked across various decentralized finance (DeFi) protocols, according to data from DeFi Pulse. While it took DeFi protocols over two and a half years to reach \$1 billion in total value locked, it took under a year for the industry to grow to \$10 billion. This rapid growth is partially attributed to the yield farming trend popularized in 2020, in which DeFi protocols offer tokens rewards to incentivize liquidity providers on their platforms. We expect for this value to continue to grow at an accelerated pace.

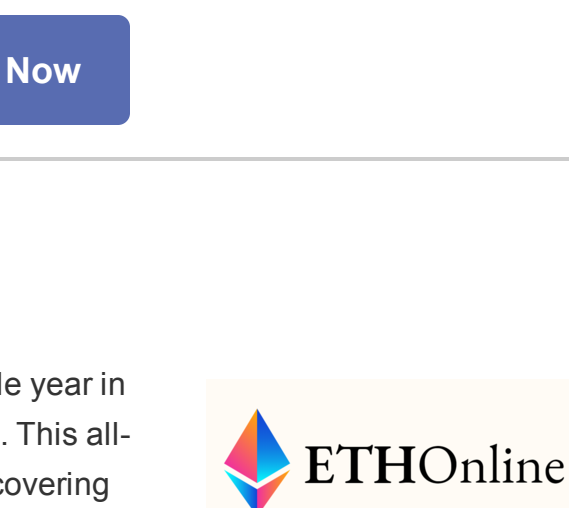

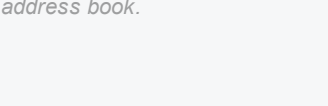

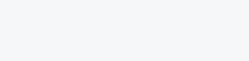
