## Technical Working Group Updates

Based on requests and discussions among the EEA Member Council, the Board has recently approved two new Interest Groups.

- The new **EEA Tokenization Interest Group**, which will help many members come to grips with issues and common needs around tokens and how to use them effectively.
- **The Ethereum 2 for Enterprise Interest Group**, which set some initial directions and goals for work over the next few months to a year during its kick-off meeting. We look forward to discussions on how the "major" evolution of the protocol impacts Enterprise use cases and technology requirements.

These two Interest Groups join the **Financial Services Interest Group** and the **Supply Chain Interest Group**, who continue to work on exploring important issues in their respective areas and how Ethereum, in general, is changing the landscape - providing opportunities and challenges.

**The Core Specifications Working Group** continues to develop requirements for interoperability of tools operating Enterprise Ethereum blockchains.

**The Testnet Group** is defining mechanisms to allow automating tests for specification conformance, and running tests as experiments.

**The EthTrust Security Levels Working Group** is determining the best way to improve the quality and reliability of security reviews across the industry.

Good standards are developed through collaboration between competitive implementers and their customers to ensure that we are solving real problems. 


